On 12/06/2016 at approximately 2:35am, patrol officers were dispatched to the Super 8 Motel, located at 5018 University Boulevard West, in reference to a person being shot. Officer's arrived to the scene to find the victim, Raquel Wallace, in motel room #124 with a gunshot wound to her person. Fire Rescue responded to the scene and pronounced the victim deceased.

Investigation revealed that Raquel was using a blue Honda Civic belonging to Amber Camarillo and was refusing to return the vehicle. Just before the shooting occurred, Amber contacted Raquel and found out the vehicle was at the Super 8 Motel and was told to bring her money in exchange for the car. In the video from the Super 8 Motel, it was observed that Amber arrived to the motel in a black Cadillac Escalade, which parks in the parking lot across from the Honda. Amber speaks with Raquel outside of room #124 then goes to the Honda and opens the driver's door. Amber is then observed coming towards Raquel and fires at least two gunshots in her direction as Raquel runs into the motel room. Amber flees the scene in the Honda, behind the Escalade which is being driven by a Hispanic male.

Later in the morning the Honda Civic and Cadillac Escalade were located in the front yard of 3640 Nicholas Circle South. Amber Camarillo and a friend were observed leaving the residence and Amber was detained on an outstanding Caplas for battery. Amber made spontaneous statements while she was being detained, saying, "I know why you are here 

Amber was transported to the homicide office and read her Constitutional Rights via form. Amber stated that a friend loaned her Honda out to an unknown female, and she, her husband and two of her husband's friends had been out looking for her vehicle all day. During the search for the Honda, Amber came across Raquel's phone number and called/texted to ask for her vehicle back. Raquel said that she wanted money for the vehicle and that Amber could retrieve her car from the Super 8 Motel. Amber arrived to room #124 and gave Raquel a

\$100.00 bill for the keys to her home. Raquel

Amber said that there were no threats made towards her, but that she got scared when she observed somebody looking through the blinds after she got to her vehicle.

Amber was convicted as a Florida Felon in Duval County on 03/22/12 for possession of cocaine.


Amber was arrested for murder and possession of a firearm by convicted felon, and then transported to the Pre-Trial Detention Facility.



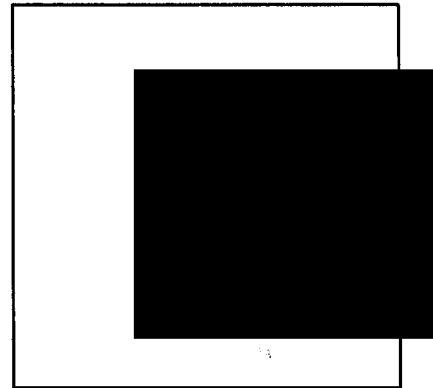
