On 08-02-2017, the victim, Savannah Page Gold left her residence, located at 10075 Dovetail Court South at 1715 hours and drove to work, Bonefish Grill, located at 10950 San Jose Boulevard. The victim was later reported missing, when her car was located in the parking lot and she did not arrive at work.

The victim is seen on video surveillance arriving in the parking lot at 1731 hours, on 08-02-2017. The victim then parks near suspect Rodarte's vehicle, and shortly thereafter she is seen getting into the passenger-side of his vehicle. At 1745 hours, the video surveillance shows what appears to be a possible struggle inside of the vehicle. Prior to leaving the parking lot, suspect Rodarte is observed walking to the victim's vehicle, opening the drivers-side door of the vehicle, and leaning inside. Suspect Rodarte is observed returning to his vehicle and at 1804 hours, suspect Rodarte's vehicle leaves the parking spot, and subsequently leaves the parking lot. At no time is the victim seen exiting the vehicle.

On 08-05-2017, suspect Rodarte was taken into custody for a Capias (FTA-LICENSE; KNOWINGLY OPER VEH W-DL SUSP, CANCELLED, REVOKED) and was interviewed at the Homicide Unit office. Prior to the interview, suspect Rodarte was clearly explained his Constitutional Rights, via form. Suspect Rodarte stated verbally he understood his rights and signed the Constitutional Rights form.

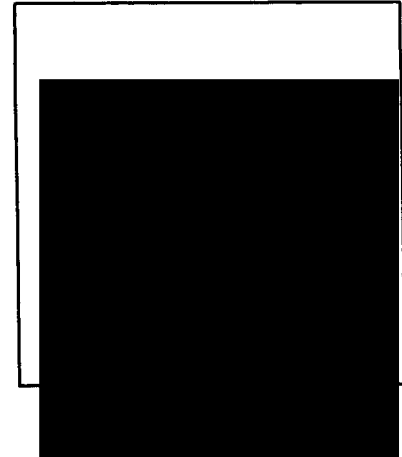
